## Postup:

1. V samostatných nádobách zmiešajte ingrediencie z fázy A a B. Zahrejte na 60 – 70 °C. Za stáleho miešania pridajte fázu A do fázy B. Homogenizujte pri 2500 – 3500 ot./min., 90 – 120 sekúnd.
2. Počas miešania nechajte zmes vychladnúť na 30 °C.
3. Za stáleho miešania pridajte fázu C a D. Homogenizujte pri 1500 – 2000 ot./min., 90 – 120 sekúnd.
4. Skontrolujte pH, v prípade potreby pridajte viac hydroxidu sodného na 5,0 – 6,0.
