Procedur:

1. Värm alla ingredienser i ett huvudkärl till 75–80°C och gör samma sak med fas B.
2. Häll det heta vattnet från fas B i fas A, blanda väl (undvik kylning) och homogenisera i 5 minuter. Börja sedan kyla formuleringen och upprepa homogeniseringen vid 60°C. Gör samma sak vid 40°C.
3. Förbered samtidigt fas C genom att blanda Xantangummi, Glycerin och varmt vatten (50°C). För att få en homogen lösning, homogenisera i 1 min.
4. Blanda ingredienserna från fas D och blanda tills det är enhetligt. Om det behövs, tillsätt citronsyra.
5. Tillsätt fas D och B till huvudkärlet (fas A) och blanda i 5 min, homogenisera sedan i 1 min.
