 2. Počas miešania pridajte Disodium Laureth Sulfosuccinate . Miešajte, kým nebude jednotná.
 3. Počas miešania pridajte PEG-120 metylglukózový dioleát. Miešajte, kým nebude jednotná. Násada sa ochladí aspoň na 30 °C.
4. Počas miešania pridajte Cocamidopropyl Betaine . Miešajte, kým nebude jednotná.
 5. Upravte konečné pH na 5,0 - 6,5 s ďalšou kyselinou mliečnou.
