Procédure:

1. Versez l'eau déionisée (25-30°C) dans le récipient principal et ajoutez le polymère croisé Acrylates/C10-30 Alkyl Acrylate. Commencez à mélanger lorsque le polymère est complètement mouillé. Mélanger jusqu'à l'obtention d'une solution homogène. Homogénéiser 1 à 2 minutes.
2. Combiner les ingrédients de la phase B dans un récipient séparé. Chauffer jusqu'à 40-45°C en agitant doucement. Mélanger jusqu'à l'obtention d'une solution homogène.
3. Ajouter lentement la phase B à la phase A en mélangeant. Mélanger jusqu'à homogénéité.
4. Ajouter le conservateur, la Cocamidopropyl Betaine et le parfum tout en mélangeant. Mélanger jusqu'à homogénéité.
