Procedimiento:

1.

Combine los ingredientes de la fase A. Agregue lentamente acrilatos/polímero cruzado de acrilato de alquilo C10-30 al agua mientras mezcla. Mezclar hasta que quede uniforme. Agregue otros componentes de la fase A. Homogeneizar con 2000-3000 RPM, 90-120 seg.

Agregue hidróxido de sodio (solución al 20%) mientras mezcla. Mezclar hasta que quede uniforme.
3.

Agregue los ingredientes de la fase C mientras mezcla. Homogeneizar con 2000-3000 RPM, 120-180 seg.
