절차:

- 3. 혼합하는 동안 PEG-120 Methyl Glucose Dioleate를 추가합니다. 균일해질 때까지 섞는다. 배치를 30℃ 이 상으로 식힙니다.
- 4. 혼합하는 동안 Cocoamidopropyl Betaine을 첨가하 십시오. 균일해질 때까지 섞는다.
