Prosedur:

1. Dalam bekas yang berasingan Saya menggabungkan bahan-bahan dari fasa A, B dan C.
2. Masukkan bahan fasa D perlahan-lahan ke fasa B sambil digaul. Gaul sehingga seragam.
3. Masukkan bahan fasa C perlahan-lahan ke fasa B sambil digaul. Homogen dengan 2000–3000 RPM, 90 saat.
4. Panaskan fasa A dan B kepada 75–80°C.
5. Masukkan A ke dalam B, kacau rata dengan kacau tangan, simpan A/B pada suhu 75–80°C. Homogen dengan 2000–3000 RPM, 120 saat.
6. Sejukkan batch hingga 50°C semasa mengadun. Masukkan bahan fasa E semasa mengadun. Homogen dengan 2500–3500 RPM, 90 saat.
7. Sejukkan batch hingga 25°C. Masukkan bahan fasa F semasa mengadun. Homogen dengan 2500–3500 RPM, 90 saat.
