Procedura:

1. Aggiungere gli ingredienti della fase A in acqua tiepida (40-45°C). Mescolare fino ad ottenere una soluzione omogenea.
2. Raffreddare il batch fino ad almeno 35°C.
3. Aggiungere gli ingredienti della Fase B durante la miscelazione. Mescolare fino ad ottenere una soluzione omogenea.
4. Sempre mescolando, aggiungere gli ingredienti della fase CE. Mescolare fino ad ottenere una consistenza uniforme.
5. Regolare il pH con acido lattico a un livello di 5,0-5,5.
