## Procedimento:

1. Combine os ingredientes da fase A. Adicione os ingredientes da fase A à água quente (75-80°C). Misture até obter uma solução homogênea. Resfrie o lote até pelo menos 50°C.

2. Adicionar Lauroil Sarcosinato de Sódio. Misture até ficar uniforme. Resfrie o lote até pelo menos 30°C.

3. Se necessário, ajuste o pH com ácido cítrico para 5,0 – 7,0.
