Procedure:

1. In de hoofdtank, fase A, verwarmen tot 70-80 °C.

2. Laat afkoelen tot 60 °C. Voeg de ingrediënten van fase B toe. Meng tot een homogene massa is verkregen.
3. Voeg de ingrediënten van fase C toe aan fase AB en meng tot een homogeen geheel. Vul de verpakking bij een temperatuur van ongeveer 50-60 °C.
