Postup:

1. V kadičke zmiešajte sklerotium a xantánovú gumu s glycerínom.
 2. V inej kadičke skombinujte Aqua s aktívnou látkou (fáza A). Premiešame a zohrejeme na 60 – 70°C. Pridajte sklerotium a xantánovú gumu s glycerínom.
 3. V hlavnej nádobe zmiešame fázu B a zohrejeme na 60 – 70 °C.
 4. Pridajte fázu A do fázy B a homogenizujte pri 2500 – 3500 ot./min., 90 – 120 sekúnd. Počas miešania sa dávka ochladí na 40 °C.
5. Zmiešajte polyakrylát sodný s EXOsoft AB25. Pridajte pokojovú fázu C a premiešajte.
 6. Pridajte fázu C do hlavnej kadičky, premiešajte a homogenizujte pri 2500 – 3500 ot./min., 90 – 120 sekúnd.
