3. Tillsätt PEG-120 Methyl Glucose Dioleate under blandning. Blanda tills det är enhetligt. Kyl satsen till minst 30°C.
 4. Tillsätt Cocoamidopropyl Betaine under blandning. Blanda tills det är enhetligt.
