2. Aggiungere ROKAcet KO400G/ ROKAnol L7/ ROKAmid MRZ11 e mescolare fino ad ottenere una soluzione omogenea.
3. Quindi aggiungere l'acido edorico e mescolare.
4. Aggiungere idrossido di sodio fino a ottenere un pH intorno a 4,5.
5. Quindi aggiungere il perossido di idrogeno e continuare a mescolare fino ad ottenere un liquido limpido.
