Procedimento:

1. Em recipientes separados, misture os ingredientes das fases A e B. Aqueça até 60–70 °C. Adicione a fase A à fase B enquanto mistura. Homogeneíze a 2500–3500 RPM, 90–120 s.
2. Deixe a mistura esfriar até 30°C enquanto estiver misturando.
3. Adicione as fases C e D, misturando bem. Homogeneíze a 1500 – 2000 RPM, 90 – 120 s.
4. Verifique o pH, se necessário, adicione mais Hidróxido de Sódio até 5,0 – 6,0.
