Procedimiento:

1. En recipientes separados combine los ingredientes de la fase A y B. Calentar hasta 75-80°C
 2. Agregue la fase A a la fase B mientras mezcla. Homogeneizar 60-90 seg. En un recipiente aparte combine los ingredientes de la fase C. Mezcle hasta que quede uniforme.
 3. Enfriar el lote a 60°C mientras se mezcla. Agregue los ingredientes de la fase C y D mientras mezcla. Homogeneizar con 2500-3500 RPM, 90 seg.
4. Enfriar el lote a 40-50°C mientras se mezcla. Agregue los ingredientes de la fase D, E y F mientras mezcla. Homogeneizar con 2500-3500 RPM, 90 seg. Enfriar el lote a 30°C mientras se mezcla.
 5. Añadir la fase F y G mientras se mezcla. Homogeneizar con 2500-3500 RPM, 90 seg.
