## Prosedur:

1. Dalam bekas berasingan gabungkan bahan-bahan dari fasa A dan B. Panaskan sehingga 60 – 70°C. Masukkan fasa A ke fasa B semasa mengadun. Homogenkan dengan 2500 – 3500 RPM, 90 – 120 saat.
2. Sejukkan kumpulan hingga 30°C semasa mengadun.
3. Masukkan fasa C dan D semasa mengadun. Homogen dengan 1500 – 2000 RPM, 90 – 120 saat.
4. Periksa pH, jika perlu, tambah lagi Natrium Hidroksida kepada 5.0 – 6.0.
