## Prosedur:

- Dalam bekas berasingan gabungkan bahan-bahan dari fasa A dan B. Panaskan sehingga 75-80°C
- Masukkan fasa A ke fasa B semasa mengadun. Homogenkan 60-90 saat. Dalam bekas yang berasingan satukan bahan dari fasa C. Gaul sehingga sekata.
- Sejukkan batch hingga 60°C semasa mengadun. Masukkan bahan fasa C dan D semasa mengadun. Homogenkan dengan 2500-3500 RPM, 90 saat.
- Sejukkan batch hingga 40-50°C semasa mengadun. Masukkan bahan fasa D, E dan F semasa mengadun. Homogenkan dengan 2500-3500 RPM, 90 saat. Sejukkan batch hingga 30°C semasa mengadun.
- Masukkan fasa F dan G semasa mengadun. Homogenkan dengan 2500-3500 RPM, 90 saat
