Procedimento:

1. Em um recipiente principal, misture os ingredientes da fase A e aqueça até 65-70°C.
 2. Adicione a goma xantana à glicerina - misture até ficar homogêneo. Adicione a fase B à fase A enquanto mistura. Misture até ficar uniforme.
3. Resfrie o lote até pelo menos 50°C.
 4. Combine os ingredientes da fase D em um recipiente separado e misture até ficar homogêneo.
 5. Adicione os ingredientes da fase C, D e E à fase A enquanto mistura. Misture até ficar uniforme.
