Procédure:

1.

Mélanger les ingrédients de la phase A. Ajouter les ingrédients de la phase A à l’eau chaude (75-80°C). Mélanger jusqu’à l’obtention d’une solution homogène. Refroidir le lot à au moins 50°C.
2.

Ajouter les ingrédients de la phase B. Mélanger jusqu’à homogénéité. Refroidir le lot à au moins 30°C.
3.

Si nécessaire, ajustez le pH avec de l’acide citrique à 5,0 – 7,0.
