Procedure:

1. Add ingredients from phase A to warm water (40-45°C). Mix until homogenous solution is obtained.
2. Cool the batch down to at least 35°C.
3. Add phase B during mixing. Mix until homogenous solution is obtained.
4. Add Phenoxyethanol and mix.
5. Adjust pH by Lactic Acid to 7.9-8.2.
6. Add phase Sodium Chloride and mix.
