 3. Verwarm fase A en B tot 75-80°C.
 4. Voeg ROKAnol LK3 toe aan fase A, houd A/A1 op 75-80°C.
 5. Voeg tijdens het mengen ROKAnol® T25 Flakes (fase B) toe aan fase A/A1. Handhaaf de temperatuur van 75-80 ° C tot het is opgelost.
6. Koel de batch af tot 50°C. Voeg fase C- en D- ingrediënten toe tijdens het mixen.
 7. Koel de batch af tot 25°C.
