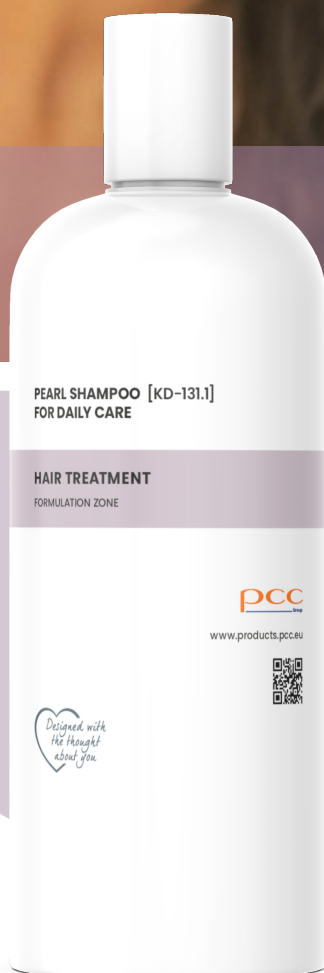

Procedura:

1. In un recipiente principale unire gli ingredienti della fase A. Mescolare fino a ottenere un composto uniforme.

2. Aggiungere ROSULfan A durante la miscelazione. Mescolare fino a uniformare.

3. Aggiungere lentamente ROKAmina K30 e Parfum durante la miscelazione. Mescolare fino a uniformare.
4. Aggiungere EXOpearl SF durante la miscelazione. Mescolare fino a uniformare.

5. Aggiungere lentamente cloruro di sodio. Mescolare fino a uniformare. NOTA: aggiungere cloruro di sodio in piccole porzioni. Controlla la viscosità dopo ogni porzione.
