Procedura:

1.

Unire gli ingredienti della fase A. Aggiungere gli ingredienti della fase A all’acqua calda (75-80°C). Mescolare fino ad ottenere una soluzione omogenea. Raffreddare il batch fino ad almeno 50°C.
2.

Aggiungi sodio lauroil sarcosinato. Mescolare fino a uniformare. Raffreddare il batch fino ad almeno 30°C.
3.

Se necessario, regolare il pH con acido citrico a 5,0 – 7,0.
