Procedimento:

1. Em um recipiente separado combine os ingredientes da fase A, A1.
 2. Prepare outros ingredientes – fases B e C.
 3. Aqueça as fases A e B a 75-80°C.
 4. Adicione lentamente a fase A1 à fase A enquanto mistura. Manter a temperatura (fase A/A1) entre 75-80°C.
 5. Adicione muito lentamente ROKanol S20 (adicione uma pequena porção enquanto mistura. Espere até ficar uniforme) à fase A/A1 durante a mistura. Manter a temperatura de 75-80°C até dissolver.
6. Adicione a fase C enquanto mistura.
 7. Resfrie o lote até 70°C.
