Procedimento:

1. Em recipientes separados, misture os ingredientes das fases A e B. Aqueça a 75-80°C.
 2. Adicione a fase A à fase B enquanto mistura. Homogeneizar 60-90 seg. Em um recipiente separado, combine os ingredientes da fase C. Misture até ficar homogêneo.
 3. Resfrie o lote até 50°C enquanto mistura. Adicione os ingredientes da fase C enquanto mistura. Homogeneizar com 2500-3500 RPM, 90 seg.
4. Resfrie o lote até 30°C enquanto mistura.
 5. Adicione as fases D e F enquanto mistura. Homogeneizar com 2500-3500 RPM, 90 seg
