Procedimiento:

1.

Combine los ingredientes de la fase A. Agregue los ingredientes de la fase A al agua caliente (75-80°C). Mezclar hasta obtener una solución homogénea. Enfriar el lote hasta por lo menos 50°C.

Añadir los ingredientes de la fase B. Mezclar hasta homogeneizar. Enfriar el lote hasta por lo menos 30°C.
3.

Si es necesario, ajuste el pH con ácido cítrico a 5,0 – 7,0.
