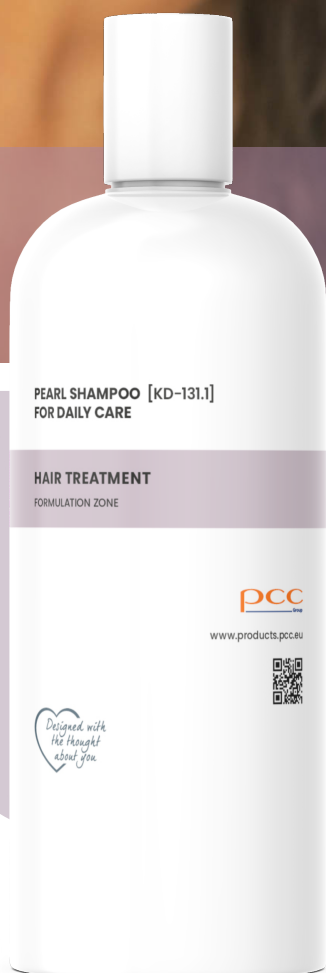

Procedure:

1. Combineer ingrediënten uit fase A in een hoofdvat. Meng tot uniform.
 2. Voeg tijdens het mixen ROSULfan A toe. Meng tot uniform.
 3. Voeg tijdens het mixen langzaam ROKamina K30 en Parfum toe. Meng tot uniform.
 4. Voeg EXOpEarl SF toe tijdens het mixen. Meng tot uniform.
5. Voeg langzaam natriumchloride toe. Meng tot uniform. OPMERKING: Voeg natriumchloride in kleine porties toe. Controleer de viscositeit na elke portie.
