Procedimento:

1. Adicione os ingredientes da fase A à água morna (40-50°C). Misture até ficar uniforme.

2. Em seguida, esfrie a mistura até a temperatura ambiente antes de adicionar um conservante e adicione o restante dos ingredientes.
3. Controle a faixa de pH – se necessário, adicione ácido cítrico. Misture bem após o ajuste.
