Procedure:

1. Combineer ingrediënten uit fase A in een hoofdvat en verwarm tot 65–70°C.
 2. Voeg Xanthaangom toe aan Glycerine – meng tot uniform. Voeg tijdens het mengen fase B toe aan fase A. Meng tot uniform.
 3. Koel de batch af tot minimaal 50°C.
4. Combineer ingrediënten uit fase D in een apart vat en meng tot een uniform geheel.
 5. Voeg al roerend ingrediënten van fase C, D en E toe aan fase A. Meng tot uniform.
