Procedura:

1. Aggiungere gli ingredienti della fase A all'acqua calda (40-50°C). Mescolare fino a uniformare.

2. Quindi, raffreddare la miscela a temperatura ambiente prima di aggiungere un conservante e aggiungere il resto degli ingredienti.

3. Controllare l'intervallo di pH – se necessario, aggiungere acido citrico. Mescolare bene dopo la regolazione.
4. Aggiungere cloruro di sodio per regolare la viscosità. NOTA. Aggiungere il sale (non in una volta sola) – dopo l'aggiunta di ogni porzione mescolare bene.
