- 2. Охолодіть суміш до 50° С, перемішуючи. Гомогенізуйте при 800–1200 об/хв, 60 сек.
- 3. Охолодіть суміш до 25°С, перемішуючи. Гомогенізуйте при 800-1200 об/хв, 30 сек.
