## prosedür:

- Ayrı kaplarda A ve B fazındaki malzemeleri birleştirin. 60-70°C'ye kadar ısıtın. Karıştırırken A fazını B fazına ekleyin. 2500-3500 RPM, 90-120 sn. ile homojenize edin.
- Karıştırırken partiyi 30°C'ye kadar soğutun.
- Karıştırırken C ve D fazlarını ekleyin. 1500 – 2000 RPM, 90 – 120 sn. ile homojenize edin.
- pH'ı kontrol edin, gerekirse 5,0 – 6,0'a kadar daha fazla Sodyum Hidroksit ekleyin.
