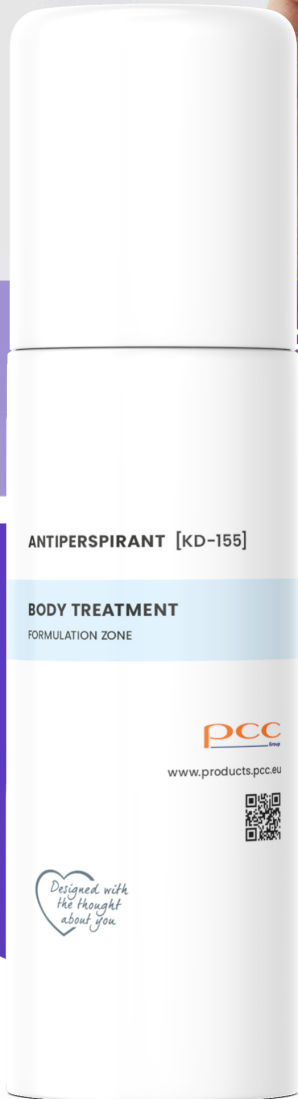

## prosedür:

- A ve B fazını 75-80°C#39;ye ısıtın.
- Karıştırırken faz B#39;yı A#39;ya ekleyin. Homojenleştirme: 1500-2000 RPM 90-120 s.
- Karıştırırken partiyi 30°C#39;ye soğutun.
- Karıştırırken faz C bileşenini ekleyin. Homojenleştirme: 1500-2000 RPM 90-120 s.
