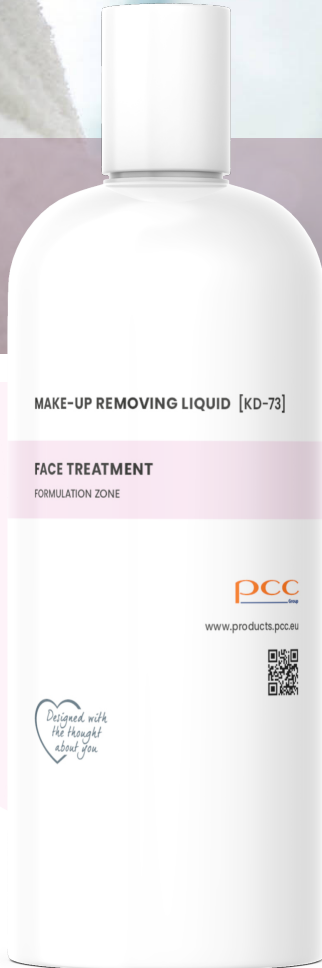

prosedür:

- A fazındaki malzemeleri birleştirin. A fazındaki malzemeleri sıcak suya (75-80°C) ekleyin. Homojen çözelti elde edilene kadar karıştırın. Partiyi en az 50°C'ye soğutun.
- B aşamasından malzemeleri ekleyin. Homojen olana kadar karıştırın. Partiyi en az 30°C'ye soğutun.
- Gerekirse Sitrik Asit ile pH'ı 5,0 – 7,0'a ayarlayın.
