Procedimento:

1. Combine os ingredientes da fase A. Adicione os ingredientes da fase A à água morna (50-55°C). Misture até obter uma solução homogênea. Resfrie o lote até pelo menos 50°C.
 2. Adicione os ingredientes da fase B enquanto mistura. Misture até ficar uniforme. Resfrie o lote até pelo menos 30°C.
3. Adicionar Cocoamidopropil Betaína durante a mistura. Misture até ficar uniforme.
