pH		5.0 – 7.0

Procedur:

1. Blanda Sclerotium och Xantangummi med Glycerin i en bägare.
 2. I andra bägare kombinera Aqua med Active Substance (fas A). Blanda och värm upp till 60 – 70°C. Tillsätt sklerotium och xantangummi med glycerin.
 3. Blanda fas B i huvudkärn och värm upp till 60 – 70 °C.
 4. Lägg till fas A till fas B och homogenisera med 2500 – 3500 RPM, 90 – 120 sek. Kyl ner satsen till 40°C under blandning.
5. Blanda natriumpolyakrylat med EXOsoft AB25. Tillsätt restfas C och blanda.
 6. Tillsätt fas C till huvudbägaren, blanda och homogenisera med 2500 – 3500 RPM, 90 – 120 sek.
