prosedür:

1. A fazındaki malzemeleri birleştirin. A fazındaki malzemeleri ılık suya (55-60°C) ekleyin. Homojen çözelti elde edilene kadar karıştırın. Partiyi en az 50°C'ye soğutun.
2. B aşamasından malzemeleri ekleyin. Homojen olana kadar karıştırın.
3. Karıştırma sırasında PEG-120 Metil Glükoz Dioleat ekleyin. Üniforma kadar karıştırın. Partiyi en az 30°C'ye soğutun.
4. Karıştırma sırasında Cocamidopropyl Betaine ekleyin. Üniforma kadar karıştırın.
5. Gerekirse, pH'ı Laktik Asit ile 4,8 – 5,3'e ayarlayın.
