pH	6.0 - 7.5 (water phase)

istikrar	5°C#39;de 1 ay, oda sıcaklığında, 40°C onaylanmış

prosedür:

1. A fazındaki malzemeleri ılık suya (40-50°C) ekleyin. Üniforma kadar karıştırın.
2. Ardından, bir koruyucu eklemekten önce karışımı oda sıcaklığına soğutun ve kalan malzemeleri ekleyin.
3. pH aralığını kontrol edin – gerekirse Sitrik Asit ekleyin. Ayarlamadan sonra iyice karıştırın.
4. Viskoziteyi ayarlamak için Sodyum Klorür ekleyin. NOT. Tuz ekleyin (tek seferde değil) – her porsiyonun eklenmesinden sonra iyice karıştırın.
