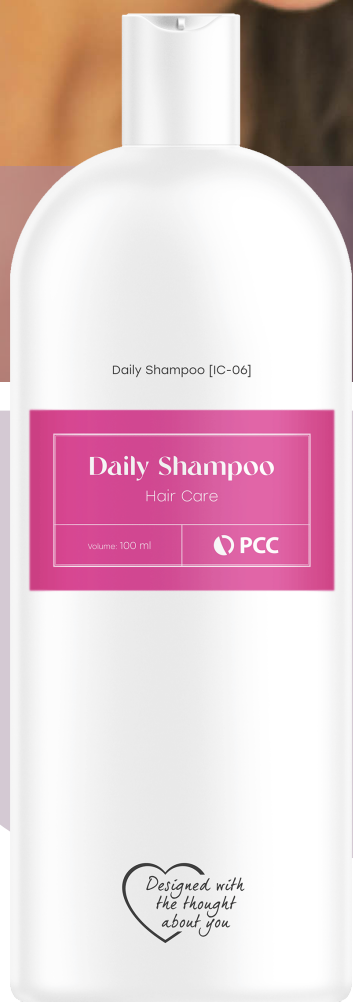

Postup:

1. Zmiešajte konzervačnú látku a betaín s vodou, kým nevznikne homogénny roztok.

2. Pridajte glycerín a premiešajte.

3. Potom pridajte SULFOROKAnol L227/1 alebo SULFOROKAnol L325 alebo SULFOROKAnol IT330 a premiešajte.

4. Pridajte ROKAtend LS a premiešajte.
5. Potom pridáme ROKAminu K30, premiešame.

6. Pridajte extrakt z ovocia Cucumis Sativus (uhorka) a premiešajte.

7. Pridajte roztok kyseliny citrónovej na dosiahnutie pH v hmote okolo 4,5–5,5.
