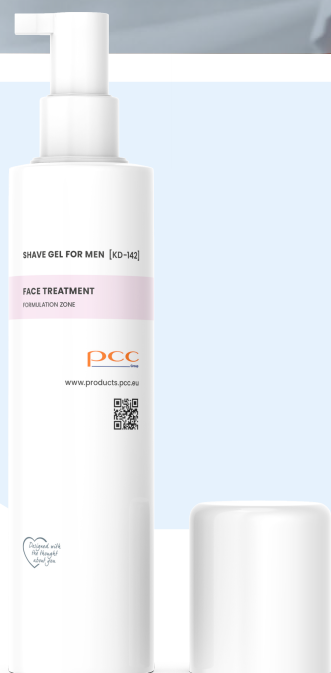

2. Počas miešania pridajte hydroxid sodný. Miešajte, kým nebude jednotná.

3. Počas miešania pridajte zložky fázy C. Homogenizujte pri 2000-3000 ot./min., 120-180 s.
