Procédure:

1. Dans un bécher, mélanger le sclérote et la gomme xanthane avec la glycérine.
 2. Dans un autre bécher, mélanger l'eau avec la substance active (phase A). Mélanger et porter à 60-70 °C. Ajouter le sclérote, la gomme xanthane et la glycérine.
 3. Dans le récipient principal, mélanger la phase B et chauffer jusqu'à 60 – 70 °C.
 4. Ajouter la phase A à la phase B et homogénéiser à 2 500 à 3 500 tr/min, 90 à 120 secondes. Refroidir le mélange à 40 °C tout en mélangeant.
5. Mélanger le polyacrylate de sodium avec EXOsoft AB25. Ajouter la phase C restante et mélanger.
 6. Ajouter la phase C au bécher principal, mélanger et homogénéiser à 2500 – 3500 tr/min, 90 – 120 secondes.
