Procédure:

1. Dans un récipient principal, combiner les ingrédients de la phase A. Ajouter la gomme xanthane à la glycérine - mélanger jusqu'à obtention d'une solution homogène. Ajouter de l'eau tiède (50-55°C). Mélanger jusqu'à l'obtention d'une solution homogène. Homogénéiser 2-3 minutes.
 2. Ajouter les composants de la phase B. Mélanger jusqu'à homogénéité. Refroidir le lot à 35°C.
3. Lorsque la température du lot est de 35°C, ajouter la Cocamidopropyl Betaine pendant le mélange. Mélanger jusqu'à homogénéité.
 4. Contrôlez la plage de pH - si nécessaire, ajoutez de l'acide lactique. Bien mélanger après ajustement.
