Procedure:

1. Combineer ingrediënten uit fase A. Voeg ingrediënten uit fase A toe aan warm water (55-60°C). Meng tot een homogene oplossing is verkregen.

2. Voeg tijdens het mengen PEG-120 methylglucosediolaat toe. Meng tot uniform.
3. Koel de batch af tot 35°C.

4. Voeg tijdens het mixen parfum en Cocamidopropyl Betaine toe. Meng tot uniform.

5. Pas indien nodig de pH met citroenzuur aan op 5,0 – 5,5.
