## Procedimiento:

1. En recipientes separados combine los ingredientes de la fase A y B. Homogeneice la fase A: 1500-2000 RPM 90-120 s.
2. Calentar la fase A y B a 75-80°C.
3. Añadir la fase B a la A mientras se mezcla. Homogeneizar: 1500-2000 RPM 90-120 s.
4. Enfriar el lote a 30°C mientras se mezcla.
5. Agregue el ingrediente de la fase C mientras mezcla. Homogeneizar: 1500-2000 RPM 90-120 s.
