Procedure:

1. Add the ingredients of phase A to warm water (40-45°C). Stir until a homogeneous solution is obtained.
2. Cool the batch to a temperature of at least 35°C.
3. Add Phase B ingredients while mixing. Stir until a homogeneous solution is obtained.
4. Add the ingredients of phase C-E while stirring. Mix until a uniform consistency is obtained.
5. Adjust the pH with lactic acid to a level of 5.0-5.5.
