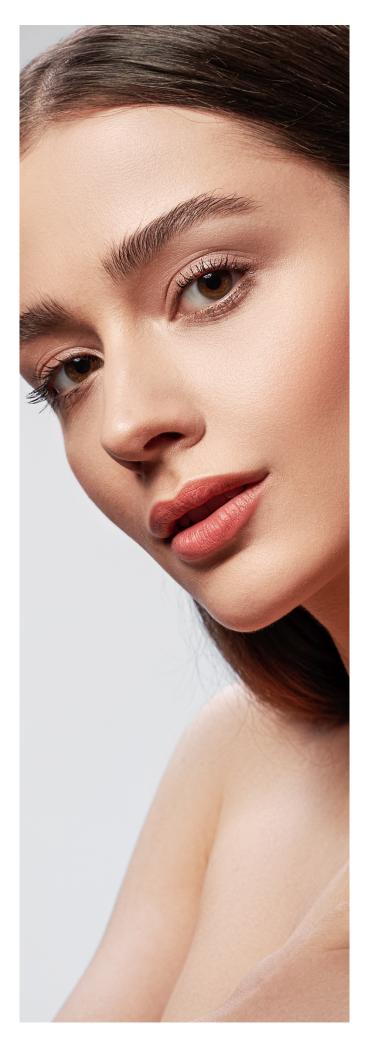

### **Procedure:**

- Add ingredients from phase A to warm water (40-45°C). Mix until homogenous solution is obtained.
- 2. Cool the batch down to at least 35°C.
- 3. Add phase B during mixing. Mix until homogenous solution is obtained.
- 4. Add phase C-E ingredients while mixing- mix until uniform.
- 5. Adjust pH by Lactic Acid to 5,0-5,5
