

- 2. Prepare the remaining ingredients in separate beakers.
- 3. Add Parfum mix until uniform.

- 4. Add slowly ROKAmina K30 while mixing mix until uniform.
- 5. Add slowly Sodium Chloride while mixing mix until uniform.
